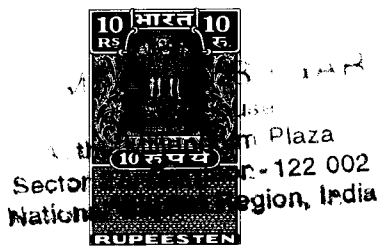



POWER OF AUTHORITY**


